Canadian Risk Management Program

The Canadian Risk Management designation (CRM) designation is a widely recognized qualification for those seeking to practice risk management. Employers in a variety of industries both public and private often identify the designation as a prerequisite for hiring. The CRM designation is awarded to students who successfully complete the three core courses in Risk Management (Risk Management Principles & Practices, Risk Assessment & Treatment and Risk Financing) by the Global Risk Management Institute (GRMI), which is a subsidiary of the Risk and Insurance Management Society, Inc. (RIMS).

The CRM designation is awarded to students who successfully complete the three core courses in Risk Management, which also comprise the risk management major of the Fellow-Chartered Insurance Professional (FCIP/FIIC).

Risk Management Courses

Risk Management Principles & Practices (36 hours)

Topics: introduction to risk management; risk management standards and guidelines; hazard risk; operational, financial, and strategic risk; risk management framework and process; risk identification, analysis, and treatment; financial statement risk analysis; capital investment and financial risk; monitoring and reporting on risk.

Risk Assessment & Treatment (36 Hours)

Topics: introduction to risk assessment and treatment; root cause analysis; business continuity management; physical property risk; intellectual property and reputation risk; legal and regulatory risk; management liability; human resource risk; environmental risk; crime and cyber risk; fleet risk.

Risk Financing (36 Hours)

Topics: introduction to risk financing; estimating hazard risk; transferring hazard risk through insurance; self-insurance plans; retrospective rating plans; reinsurance; captive insurance; contractual risk transfer; transferring financial risk; transferring hazard risk to the capital markets; allocating costs of managing hazard risk.

*Although the Risk Management Principles & Practices course is recommended for the Risk Assessment and Treatment and Risk Financing courses, we can often make exceptions. Where someone has been employed for a while in the risk, insurance, legal or engineering realms, they are fine to take the courses in any order.
